# Sailors For Cindy

VIRGINIA BEACH — There were no angry speeches. No shouting. Just the soft flicker of hand held candles illuminating faces, young and old.

Except for some anti-war sentiments scrawled on a few signs, it was hard to tell why about 200 people had gathered in vigil Wednesday night at Town Center. That is until the first soft voice in song cut through the din of conversation and laughter like a bullet.

“All we are saaaaaying, is give peace a chance....”

"Twenty-four kids died this week" fighting for the U.S. in Iraq, said Chris Permenter, 17, a senior at Cape Henry Collegiate School in Virginia Beach who came with several classmates. "They could have been any one of us."

**Betty Cyrus, 49, of Virginia Beach, held a photo of her son, Andy Keffalas, who is serving in the Navy.**

**"I didn't think the war was going to go well before it even started," she said. "And it hasn't. Now we are stuck over there killing people – and being killed."**

The gathering was one of hundreds nationwide in support of Cindy Sheehan whose son, an Army soldier, was killed in Iraq in April 2004.

**While the crowd at Town Center was made up largely of civilians, there were numerous retired and even active-duty military members present.**

**"After 9/11, all I wanted was a way to Afghanistan and an axe," said Bill Everett, a lieutenant in the Naval Reserve.**

**Back then, he thought the war was just and said he believed Bush.**

**No more, however.**

**"It's all about the oil and money," Everett, 29, said. "It's not about protecting the American people, and that's what I signed up for."**

**As he spoke, a few men passed by, one muttered a denunciation of the demonstration, saying it did not support the troops.**

**Everett's response was swift.**

**"I am in the service," he shot back, waving his military ID card.**

Everett, served aboard the amphibious assault Nassau in 2002 and 2003 when a routine six-month deployment became nine months at sea at the start of the war. He entered the reserves last year.

He said its time to leave Iraq to the Iraqis.

"Let them settle it among themselves and if they want a religious government, then let them have it," Everett said. "Bush wants religion in government here."

**Bryan Brooks, 23, a nuclear electrician aboard the carrier Enterprise , said he is disillusioned with the war because the basis for invading Iraq was its possession of weapons of mass destruction. But that proved to be "definitely, definitely wrong," he said.**

**"You can oppose the war and still love your country," Brooks said.**

And if called to fight, he said he'll obey. "I will do as I am told," Brooks pledged, "even if I don't agree."

# **“Doyle Told Her He Wanted To Come Home”**

A soldier with ties to the Eastern Shore has been killed in Iraq, his family said.

Army Staff Sergeant Jeremy Doyle, 24, was one of four men killed Thursday when their Humvee hit a land mine in the Iraqi city of Samarra, according to his mother, Debbie Grove, of Pocomoke City.

**Grove tells WBOC-TV in Salisbury that when she talked to her son three weeks ago, Doyle told her he wanted to come home.**

Doyle was a handful growing up, Grove said, but he was lovable.

"He was the class clown," she said. "You know, he didn't like to do his work, but the teachers loved him because he was the class clown."

**Doyle's sister, Cammie, says it has been tough since they learned of his death.**

**"You keep thinking it's just a dream and you're going to wake up. But it never is," she said.**

Doyle had been in Iraq since January and was based at Fort Stewart in Georgia.

His family said he leaves a behind a wife, Leah.

# St. Lake City Mayor Calls For Mass Action Against Bush Visit & War On Monday

**"Patriotism," the mayor said, "demands that people speak out when we see our government officials acting in such anti-democratic and deceitful ways to the people of our country."**

**Salt Lake City Mayor Rocky Anderson called for "the biggest demonstration this state has ever seen" to protest President Bush's appearance Monday before a national veterans convention.**

**"This administration has been disastrous to the country," Anderson said Friday.** "If people could organize and speak out in an effective manner from the reddest state in the country, that would garner a lot of attention."

**In an e-mail Wednesday to about 10 activist leaders, the maverick mayor of Utah's capital called for a diverse demonstration to greet Bush when he speaks to the Veterans of Foreign Wars at the Salt Palace Convention Center. The mayor plans to join the protesters.**

"There should be a collaboration of health-care-provision advocates, seniors, the (gay, lesbian and bisexual and transsexual) community, anti-Patriot Act advocates and other civil libertarians, anti-war folks, pro-Social Security advocates, environmental advocates, anti-nuclear-testing advocates, and anti-nuclear-waste-shipment-and-storage advocates," the mayor wrote in the e-mail.

The mayor's message drew a howl of outrage from Mike Parkin, senior vice commander of Veterans of Foreign Wars Atomic Post 4355 in Salt Lake City. "Excuse my French, but - that son of a bitch!" he said. "It makes the mayor look very, very unpatriotic. It makes him look despicable."

**Parkin said such demonstrations, particularly against the Iraq war, give comfort to America's enemies** and will be particularly offensive to the 13,000 to 14,000 veterans gathering at the convention. **[The man is confused. The demonstration can't possibly be construed as giving Bush any comfort.]**

"I voted for the son of a bitch and I'll never vote for him again," said the Vietnam War veteran.

Anderson disagrees with that measure of patriotism.

**"Patriotism," the mayor said, "demands that people speak out when we see our government officials acting in such anti-democratic and deceitful ways to the people of our country."**

## **#1 Letter To Tacoma News Tribune**

Dear Mr. Gilbert,

**I am the mother of a young Army MP who returned from a tour of duty in Iraq, as well as a personal friend of Cindy Sheehan.**

It was appalling to read an article appearing in the Washington Post, on August 14, entitled "US LOWERS SIGHTS ON WHAT CAN BE ACHIEVED IN IRAQ". The 3<sup>rd</sup> paragraph quotes unnamed U.S. officials saying, "What we expected to achieve was never realistic given the time table or what unfolded on the ground. We are in a process of absorbing the factors of the situation we're in and shedding the unreality that dominated at the beginning."

The UN-REALITIES perpetrated by the Bush Administration:

1. Iraq has WMDs
2. Iraq has connections to Al-Qaeda
3. Iraq is an "imminent threat" to the United States

Those were the reasons given to Congress by the president of the United States, in his executive order, to garner their vote that gave over their power to declare war, to him. These claims have been undeniably proven to be false and the White House has publicly admitted to that.

The Iraq war not only flies in the face of international law, but is a blatant violation of our own constitution, Article 1, Section 8. These are facts, not conjecture.

After reading your above mentioned article, I felt obligated, as a personal friend of Cindy Sheehan, a mother of a young Iraqi Veteran, and a citizen of Pennsylvania, to respond to Rep. Platt's war stance.

First, and foremost, freedom and democracy are not effectively implemented from the end of a gun barrel.

Mr. Platt's reference to "those who torture them" can be appropriately applied to what our own troops are inflicting on ordinary Iraqis on a daily basis, in one CENTCOM report after another.

Maybe Mr. Platt has not found the time to look beyond the Abu Ghraib scandal. If he had, he would have found out about the 11 Baghdad Task Force soldiers charged with abuse and torture of detainees.

**She soon bumped that estimate up, after word of mouth seemed to indicate many more planned to be there. But the turnout Wednesday night was beyond her expectations.**

**"It's a nice surprise," said Braiman, a Brighton resident, of the hundreds of people who packed the gazebo area. "It feels energizing, especially when you figure there are 1,500 of these (demonstrations) going on tonight in our country."**

Some carried signs with messages such as "Stop the War" and "Bring our Children Home." Some began singing "We Shall Overcome," a theme song from the Civil Rights era.

**Linda Rapkin of Brighton had thoughts about the huge turnout.**

**"There has been no way, up to now, to express ourselves," said Rapkin, a retired city school teacher. "If you did, you were deemed unpatriotic."**

Rapkin said the Bush administration has to provide better benefits for veterans returning from Iraq. The president also has to resolve problems involving reservists who go to war, then return home to find they have no jobs, she said.

**Several motorists who drove by the area honked their car horns in support.**

"This is repeated over and over again throughout our country," said Brighton Supervisor Sandra Frankel, who spoke to the crowd through a bullhorn. "We need President Bush to speak to Cindy Sheehan and all the moms and dads who are hurting. We need closure."

**Frankel noted that two former Brighton residents — Army Warrant Officer Eric Smith and Navy Petty Officer 1st Class Michael Pernaselli — have died in Iraq. Both left grieving families behind, as was the case with Cindy Sheehan, said Jon Greenbaum of Metro Justice.**

"Cindy Sheehan is not alone," he said.

**CINDY SHEEHAN: I want to ask him what was the noble cause that Casey and the others have died for, because he keeps on saying that they died for a noble cause, and I don't think a war of aggression against a nation that was no threat to the United States of America is a noble cause.**

And I'm not going to let him tell me about keeping America safe for freedom and democracy, because he told us before he invaded that it was about weapons of mass destruction and Saddam Hussein with some kind of a link to al Qaeda.

**And that's been proven wrong, and it's been proven wrong consistently, and the Downing Street memos prove that as early as July of 2002, they knew that that was wrong and they had to fabricate the intelligence to fit their policy of invading Iraq.**

*AMY GOODMAN: Where did your son die?*

CINDY SHEEHAN: He died in Sadr City, Baghdad, in an ambush on April 4, 2004.

And if I had known that, you know, if I had known what was going to happen to him, I think I probably would have tried to force him into Canada or something, but, you know, he was an adult, and he thought it was his duty, and so I was as supportive as I could be. He was only there for five days, though, before he was killed.

**FALLUJA - Four Iraqi soldiers were killed and three wounded when an insurgent hurled a hand-grenade at a passing Iraqi army patrol in Falluja, west of Baghdad, a police officer said.**

"The incident occurred at 10:30 am (0630 GMT) today in the western Andalus neighbourhood of Fallujah," police captain Juwad Abdul Latif said.

Medics confirmed receiving the bodies of three soldiers. The defence ministry acknowledged there had been an attack but declined to give details.

**Four more Iraqi soldiers were killed near the northern town of Shorgat when rebels hit their patrol car with a rocket, a police source said.**

**Two Iraqi commandos were also killed and two wounded when gunmen opened fire on their patrol in Al-Amiriyah on the western outskirts of the capital, a police source said.**

**In Baghdad, two policemen were killed in a gunfight on Saturday morning with militants near Al-Shurta tunnel in the Amiryaa neighborhood, Capt. Talib Thamir said.**

**An Iraqi contractor who worked with the US army was also shot dead by guerrillas near Kirkuk.**

**A roadside bomb exploded near a convoy of Kurdish militiamen, wounding six on the Mosul's southern outskirts.**

The media are wrong. The people who have come out to Camp Casey to help coordinate the press and events with me are not putting words in my mouth, they are taking words out of my mouth.

**I have been known for sometime as a person who speaks the truth and speaks it strongly. I have always called a liar a liar and a hypocrite a hypocrite. Now I am urged to use softer language to appeal to a wider audience. Why do my friends at Camp Casey think they are there? Why did such a big movement occur from such a small action on August 6, 2005?**

I haven't had much time to analyze the Camp Casey phenomena. I just read that I gave 250 interviews in less than a week's time. I believe it. I would go to bed with a raw throat every night. I got pretty tired of answering some questions, like: "What do you

want to say to the President?" and "Do you really think he will meet with you?" However, since my mom has been sick I have had a chance to step back and ponder the flood gates that I opened in Crawford, Tx.

I just read an article posted today on LewRockwell.com by artist Robert Shetterly who painted my portrait.

**The article reminded me of something I said at the Veteran's for Peace Convention the night before I set out to Bush's ranch in my probable futile quest for the truth. This is what I said:**

**"I got an email the other day and it said, "Cindy if you didn't use so much profanity ... there's people on the fence that get offended.**

**And you know what I said? "You know what? You know what, god damn it? How in the world is anybody still sitting on that fence?**

**If you fall on the side that is pro-George and pro-war, you get your ass over to Iraq, and take the place of somebody who wants to come home. And if you fall on the side that is against this war and against George Bush, stand up and speak out."**

**This is what the Camp Casey miracle is all about. American citizens who oppose the war but never had a conduit for their disgust and dismay are dropping everything and traveling to Crawford to stand in solidarity with us who have made a commitment to sit outside of George's ranch for the duration of the miserable Texan August.**

If they can't come to Texas, they are attending vigils, writing letters to their elected officials and to their local newspapers; they are setting up Camp Casey branches in their hometowns; they are sending flowers, cards, letters, gifts, and donations here to us at Camp Casey. **Everyday at Camp Casey we have a couple of anti-peace people on the other side of the road holding up signs that remind me that "Freedom isn't Free" but I don't see them putting their money where their mouths are. I don't think they are willing to pay even a small down payment for freedom by sacrificing their own blood or the flesh of their children.**

**I still challenge them to go to Iraq and let another soldier come home. Perhaps a soldier that is on his/her third tour of duty, or one that has been stop-lossed after serving his/her country nobly and selflessly, only to be held hostage in Iraq by**

**power mad hypocrites who have a long history of avoiding putting their own skin in the game.**

Contrary to what the main stream media thinks, I did not just fall off a pumpkin truck in Crawford, Tx. on that scorchingly hot day two weeks ago. I have been writing, speaking, testifying in front of Congressional committees, lobbying Congress, and doing interviews for over a year now. **The aim of any serious anti-war protest is to force a government to quit fighting, pull the troops out, come home right now.**

**But Sheehan is castigated in the press, by mainstream liberals as well as mad-dog rightists, for not leaving any wriggle-room on this central point. She says, Bring the troops home right now.**

**How many people echo that straightforward demand? Millions of ordinary Americans around 34 per cent certainly do, if we are to believe the numbers in polls that also give Bush an approval rating of only 34 per cent for his conduct of the war.**

But to be effective the opinion of ordinary people has to be harnessed into a powerful political movement that offers energetic leadership.

Here the picture is dismayingly cloudy. MoveOn.org, has used Sheehan's siege of Bush as springboard to mount supportive anti-war vigils.

**But what exactly is MoveOn calling for, in terms of ending the war?**

**Go to the website of the Win Without War coalition, of which MoveOn is a member along with groups ranging from the Sierra Club, to National Organization of women to the Methodists, Unitarians and Quakers and you'll find a mush-mouth statement about "a gradual, phased decrease in numbers rather than augmenting the size of the force", plus other familiar boilerplate about how the UN Security Council "should authorize and encourage the creation of an international stabilization force to assist the Iraqi authorities with security and training of Iraqi forces."**

**This leisurely agenda doesn't add up to anti-war leadership. After all, Gen. George Casey, the US commander in Iraq, talks bluntly about "some fairly substantial reductions" to start next spring.**

**It's no secret why MoveOn and Win Without War are so timid.**

**Square in their field of vision is the Democratic Party whose high-profile congressional leaders such as Hillary Clinton and Joe Biden are calling for more troops to be shipped out to Iraq. Push comes to shove, most of the Win Without War coalition members won't get more than half a beat out of step with the Democrats.**

**Serious resistance, of the sort Sheehan calls for, has to throw the threat of popular sanction over both Democrats as well as Republicans.**

**Anyone can go on a vigil. It only costs the price of a candle and a solemn expression. The price of entry into serious antiwar organizing at the crucial moment is steeper. It requires political nerve. A substantial coalition has to lead the way, pointed to by Sheehan, with the slogan Bring Them Home Now.**

**What truly frightens governments is mutiny or the threat of mutiny. Gold Star moms like Cindy Sheehan could be leading sit-ins at military recruitment offices across the country and in the home district congressional offices of Democrats and Republicans.

How about Cindy Sheehan moving Camp Casey from Crawford to Hillary Clinton's offices in Washington or New York. Only this time the demand would not be for a meeting but for a reversal of HRC's pro war position which has her putting up a bill to increase US forces overall by 90,000.

One of the greatest achievements of the antiwar movement in Vietnam era was to make it untenable for a Democrat, LBJ, to run again for the presidency, or for Hubert Humphrey to run and win on a prowar platform. Question, would the MoveOn operation take the slightest interest in any vigils outside HRC's offices, or those of any other prominent Democrat? Of course not.

"And I look at the situation and I -- in my mind, I think of the number of people who are lost to traffic accidents in the United States in a given year. I think of any one of our major cities, where two or three hundred people are killed by homicides. And you ask how long will we tolerate it?"

The article about the Navy wife denied funding for an abortion has no relevancy to the war. Perhaps you're not aware that there are pro-lifers in the antiwar movement, and I'm not the only one. I am of an anarchist bent and my position is a personal moral view; I don't address legal/political aspects, but I am a pro-lifer nonetheless.

While again, it has no relevancy to opposing the war, my view is that I don't see how aborting a deformed fetus is superior to letting nature take its course. It's not as though the mother's life was in danger, and abortions are not exactly a healthy procedure for a woman to undergo.

Nature sometimes makes mistakes, but human solutions to those mistakes are not necessarily the ideal solutions. I have known a woman who gave birth to a child who was anencephalic and it had no negative effect on her health and physical stamina. An abortion on the other hand is a very invasive procedure that is not good for a woman's body. Such things are extremely traumatic, but having an abortion does not stop or heal the pain.

I just think you should be a little more aware of your audience and not assume that we all agree with your take on this.

Since it has nothing to do with opposing the war, I think it would be better for the antiwar movement not to drag it in. For all you know, Monica Benderman and Cindy Sheehan might be pro-lifers, too -- I know that J[xxx]'s mother is, and so is T[xxx] - and while I don't actually know, if I were to guess, my guess would be that they are, too.

I march against the war with women who are also pro-abortion choicers and I maintain friendships with them.

I just don't discuss the subject. It's not worth it.

### **REPLY:**

The article in question has to do with a federal appeals court in San Francisco ruling Thursday that the Navy need not pay for an abortion received by a sailor's wife, even though doctors said the fetus had a birth defect and could not survive. This meant the military family got stuck with a bill for several thousand dollars.

The woman terminated her pregnancy in 2002 after she learned that her fetus had no forebrain or cerebellum, a fatal condition known as anencephaly. Because her husband was in the Navy, the woman was covered under the military's health plan, the Civilian Health and Medical Program for the Uniformed Services, or Tricare.

But Tricare administrators said they were barred from paying for the abortion. Federal law prohibits payment for abortions except "where the life of the mother would be endangered if the fetus were carried to term."

This federal law denies payment for abortions for military personnel even in cases of rape or incest. That is legislation worthy of the days when it was unlawful to write that

the world was round, when women were chattels like cows, and slavery was held to be God's lawful will.

Whether or not any given individual does or does not wish to have an abortion is that individual's decision, and in this instance, her decision was reasonable and medically sound, whatever others may think of it from any other point of view. People may have honest disagreements about that, but the choice is hers, not theirs.

What is intolerable is when some politicians decide to punish people who choose to have an abortion, as in this case, even though people who are for a woman's right to choose are the majority of Americans. It's even worse for people in the military, who do not have the option of choosing their health care plans.

This court decision was denounced in GI Special as an abuse generally, and a vicious, cruel abuse of this family in particular for exactly that reason, and rightly so.

People who decide against an abortion for any reason in this type of situation have the right to the best medical care, and for military people, would be charged nothing for it.

People who decide for an abortion in this type of situation have the right to the best medical care, and should be charged nothing for it. But that's not how it is, as this case so perfectly illustrates.

Neither people for or against abortions have the slightest right to dictate law to others about whether or not they may, should, or can have an abortion, including dictating the terms and conditions of medical care for those who do not agree with them.

There is no difference whatever between saying that if she chooses not to have an abortion, the military would stop paying for her treatment to term because the fetus could not live, than saying that if she chooses not to carry to term, the military won't pay for ending the pregnancy. None.

And no one should be punished for refusing to bow down before the religious views of lawmakers, whether financially or otherwise. And that's exactly what is happening in this case.

That's the issue here, not one's own personal view of abortion, which someone may or may not wish to discuss, depending on the time, place and circumstances. This is a matter of invidious treatment and punishment by law.

Since inception, GI Special has carried articles denouncing all kinds of abuses of military personnel, and their families, ranging from government schemes to close commissaries, to failures to provide certain educational benefits for people in the armed services for over ten years, to the way officers hogged handicapped parking on some bases although in the best of health.

None, previously, have ever been objected to as not directly related to the war. None, obviously, were directly related to the war. So that's not the issue here either.

This is not about who marches with who at a rally or demonstration against the war, either. This is about punishing women in the armed services medical plan financially for a lawful medical decision.

And no, there will be no retreat from asserting a women's right to free, safe abortion on demand, civilian or military. Or her equal right not to have an abortion, with free, safe medical care to term, regardless of the expenses involved in this or other cases, however hopeless the prospects for the life of the fetus or how monstrous the deformity. Neither view will be silenced when a member of the armed forces or military family member is shit on.

No one has the right to dictate to the woman what her choice is to be, though the application of legally sanctioned financial blackmail, as in this case, or in any other way.

As Malcolm X used to say, "Let it be even Steven."

Given the will of the majority of Americans on this question, were this society anything remotely resembling a democracy, the issue of payment for her care would never have arisen.

And the problem of unrepresentative government, by the way, has a great deal to do with the war, more so every day.

The same hypocrites in Washington who practice mass death in Iraq posture about their commitment to life on the abortion question.

Unlike those politicians, the writer here is consistent and principled, in opposing both abortion and the war on the same grounds, and one would assume, opposing the death penalty as well.

That is everyone' right, and need not be divisive, provided they do not support imposing their views on others by the application of legal force and the denial of benefits to members of military families.

And that was the question raised by what happened to this navy wife, not the right or wrong of abortion in the abstract.
