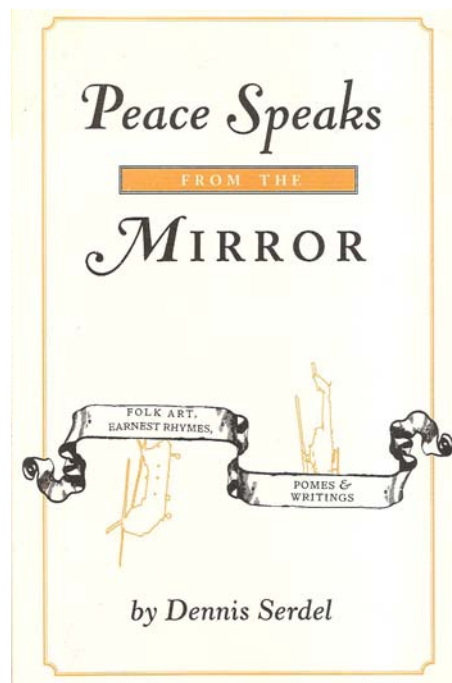

## IRAQ WAR REPORTS

### Resistance Action

**ANBAR: The director of the emergency police in Amiriyat al-Falluja district has been killed in an improvised explosive device (IED) blast in Ramadi city, according to a local source.**

“On Monday noon, Captain Ibahim Khayrallah was killed when a sticky IED targeted his vehicle near the residential compound in Amiriyat al-Falluja district, southern Ramadi,” Maj. Yasseen Mohammed told Aswat al-Iraq news agency. “One of the director’s companions was wounded as a result of the explosion,” the major pointed out.

**NINEWA: A U.S.-allied chieftain on Monday was killed in Ninewa and his driver was wounded when a sticky bomb attached to their car went off in central Mosul city, a police source said.**

“Sheikh Mohammed Fadil al-Hayiali was killed at al-Dowasa neighborhood, central Mosul,” the source told Aswat al-Iraq news agency. The incident took place near a restaurant in the area,” he said. The source pointed out that the wounded driver was admitted to hospital while the chieftain’s corpse was delivered to the city’s morgue.

“Sheikh al-Hayiali is one of the supporters of the Sahwa (awakening) councils in Ninewa,” he noted.

Mosul, the capital city of Ninewa province, lies 405 km north of Baghdad.

Six policemen were injured when an improvised bomb targeting a police patrol exploded in Yarmuk area west of Mosul

A roadside bomb wounded one policeman in central Kirkuk, 250 km (155 miles) north of Baghdad, police said.

Police found the body of policeman who had been shot in the head and chest near Kirkuk, police said.

A bombing that targetted a police patrol in the central Mosul district of Karaj Baghdad, killed a policeman.

Insurgents shot and killed a policeman in Mosul, 390 km (240 miles) north of Baghdad, police said.

A sticky bomb killed a local tribal leader and wounded his driver in Mosul, police said. Police had earlier said three people were wounded in the blast, but later said only the driver had been hurt.

It is with great regret that the Ministry of Defence must confirm that Bombardier Craig Hopson from 40th Regiment Royal Artillery (The Lowland Gunners) was killed in Afghanistan on Saturday 25 July 2009.

Bombardier Hopson was killed when the Jackal vehicle in which he was travelling struck an improvised explosive device while taking part in Operation PANCHAI PALANG.

Bombardier Hopson was part of a patrol in the Babaji area of Helmand province, tasked to recce a suitable area for a polling station in the forthcoming Afghan presidential elections.

## **Roadside Bomb Damages Occupation Military Vehicle In Wardak; Casualties Not Announced**

A roadside bomb struck military convoy of the international troops in Wardak province, 40 km west of Afghan capital Kabul, Monday damaging one military vehicle, spokesman of provincial administration Shahidullah Shahid said.

"The incident occurred between provincial capital Maidan and Jalriz district at 08:00 a.m. local time (0330 GMT) damaging an armored personnel carrier," Shahid told Xinhua.

However, he did not say if there were any casualties.

## **Taliban New Rules: "The Mujahideen Have To Behave Well And Show Proper Treatment To The Nation, In Order To Bring The Hearts Of Civilian Muslims Closer To Them"**

The Taliban in Afghanistan has issued a book laying down a code of conduct for its fighters.

Al Jazeera has obtained a copy of the book, which further indicates that Mullah Omar, the movement's leader, wants to centralise its operations.

The book, with 13 chapters and 67 articles, lays out what one of the most secretive organisations in the world today, can and cannot do.

It talks of limiting suicide attacks, avoiding civilian casualties and winning the battle for the hearts and minds of the local civilian population.

Al Jazeera's James Bays, reporting from the capital, Kabul, said every fighter is being issued the pocket book entitled "The Islamic Emirate of Afghanistan Rules for Mujahideen".

The book sheds considerable light on the structure, organisation and aims of the group, he said.

"If unofficial groups or irregular battalions refuse to join the formal structure, they should be disbanded," Omar says.

While the Taliban have repeatedly used suicide bombings across Afghanistan, the book now says that they should be used only on high and important targets."

"A brave son of Islam should not be used for lower and useless targets. The utmost effort should be made to avoid civilian casualties," the book says.

There are now clear guidelines on how the Taliban will treat its prisoners as well.

"Whenever any official, soldier, contractor or worker of the slave government is captured, these prisoners cannot be attacked or harmed," it says.

"The decision on whether to seek a prisoner exchange or to release the prisoner with strong guarantees will be made by the provincial leader.

"Releasing prisoners in exchange for money is strictly prohibited."

The book further states that if a "military infidel" is captured, the decision on whether to kill, release or exchange the hostage is only to be made by the Imam, a reference to Mullah Omar, or deputy Imam.

The book makes it clear that it is the duty of every fighter to win over the local population.

"The mujahideen have to behave well and show proper treatment to the nation, in order to bring the hearts of civilian Muslims closer to them.

"The mujahideen must avoid discrimination based on tribal roots, language or geographic background."

Our correspondent said the reference to winning over the hearts of the Afghan people is very similar to language used by Nato-led military forces in the country.

“Recently the Nato commander here issued a new tactical directive saying that civilians should not be bombed - almost the same words in these regulations to Taliban fighters,” Bays said.

“Both sides trying to win over the civilian population in their area.”

The release of the rule book comes less than a month before Afghans head to the polls for a presidential election, which the Taliban has deemed an illegitimate system imposed by foreigners.

The timing may be just a coincidence, however, as rival presidential candidates detail their manifestos and the Taliban makes an effort to win over the Afghan public.

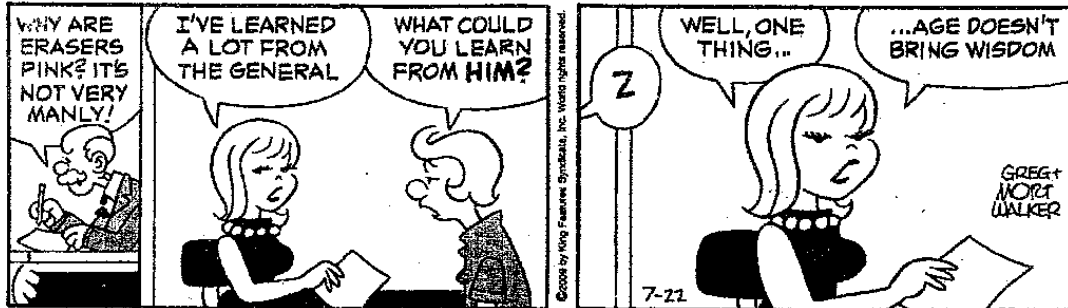

# The Withdrawal Of All Intelligence, Surveillance And Reconnaissance Assets From The Area”

A member of the Senate Armed Services Committee and an Army historian are raising serious questions about the performance of Army commanders prior to an assault that killed nine U.S. soldiers at a remote outpost in eastern Afghanistan last July.

Sen. James Webb (D-Va.) said he has asked the Pentagon's inspector general to conduct a formal examination of the Taliban assault and suggested that the Army may have mishandled an investigation of the incident.

The attack on the outpost in the village of Wanat was among the deadliest of the war in Afghanistan. The Army concluded a few months later that Afghan government leaders in the area had conspired with the enemy before the assault.

The investigation largely absolved senior Army leaders in the area of any serious errors related to the incident.

In a July 9 letter, Webb asked the Pentagon's then-acting inspector general to have his office look into the incident. “I believe a more thorough consideration of senior command accountability is warranted,” the senator wrote.

The letter cites an unreleased draft report written by an Army historian at Fort Leavenworth, Kan., that is sharply critical of the way senior Army leaders in Afghanistan performed before the assault.

**Soldiers at the remote base were short of basic necessities such as water and sandbags and repeatedly complained that they were in a precarious position, according to the historian's report.**

A few days before the assault, a U.S. helicopter attack mistakenly killed all of the Afghan doctors and nurses from a local clinic, infuriating villagers throughout the area, according to Douglas Cubbison's draft report.

**Lt. Jonathan P. Brostrom, the platoon leader who was killed at the Wanat base, sent word up to his senior commanders that he was worried that a retaliatory attack was imminent, the draft report states.**

Rather than bolstering security, officers at Bagram air base ordered the withdrawal of all intelligence, surveillance and reconnaissance assets from the area.

Brostrom's father, retired Army Col. David. P. Brostrom, alerted Webb's office to the Army historian's report. "After I read the report, I was sick to my stomach," Brostrom said.

The existence of the document was first reported on the Web site of Foreign Policy, which is owned by The Washington Post Co.

## **Investigation Finds War Profiteer KBR And Incompetent Army Commanding Officers Responsible For Electrocuting Troops In Iraq; "Military Commanders And Key Decision Makers Failed To Ensure That Renovations Were Properly Performed And Did Not Address The Maintenance Situation"**

WASHINGTON — Military leaders and a major military contractor failed to protect a Green Beret who was electrocuted while showering in his barracks in Iraq, the Defense Department's Inspector General determined.

The early 2008 death of Staff Sgt. Ryan Maseth, 24, of Pittsburgh, triggered an investigation by the IG of Maseth's death, but also a review of 17 other electrocution deaths in Iraq. Uprouar over it also led to the electrical inspections of about 90,000 U.S.-maintained facilities in Iraq, which are ongoing.

The inspector general says in its findings to be released later Monday that "multiple systems and organizations" failed and exposed Maseth to "unacceptable risk."

Maseth was electrocuted while showering when he came in contact with an energized metal shower and hose caused by the failure of an ungrounded water pump located on the roof of the building, the IG said. I

t says Houston-based military contractor KBR Inc. installed the pump and adjacent water tanks.

**KBR did not ground equipment during installation or report improperly grounded equipment during routine maintenance, the inspector general said. It also says KBR did not have standard operating procedures for the technical inspection of facilities.**

**But it also says military commanders and key decision makers failed to ensure that renovations were properly performed and did not address the maintenance situation.**

Of the 18 electrocution deaths in Iraq, nine were blamed on touching live electrical wire or cables and didn't warrant further review by the IG, according to the summary. Eight involved possible equipment faults or malfunctioning that caused or contributed to the electrocutions, the IG found.

It says it asked military criminal investigations to reopen investigations into four of the deaths, and is still waiting for the results of the review.

In 2005, I was the youngest person elected to the new Afghan parliament. Women like me, running for office, were held up as an example of how the war in Afghanistan had liberated women.

But this democracy was a facade, and the so-called liberation a big lie.

You must understand that the government headed by Hamid Karzai is full of warlords and extremists who are brothers in creed of the Taliban. Many of these men committed terrible crimes against the Afghan people during the civil war of the 1990s.

For expressing my views I have been expelled from my seat in parliament, and I have survived numerous assassination attempts. The fact that I was kicked out of office while brutal warlords enjoyed immunity from prosecution for their crimes should tell you all you need to know about the “democracy” backed by Nato troops.

So far, Obama has pursued the same policy as Bush in Afghanistan.

Sending more troops and expanding the war into Pakistan will only add fuel to the fire.

Like many other Afghans, I risked my life during the dark years of Taliban rule to teach at underground schools for girls.

Today the situation of women is as bad as ever. Victims of abuse and rape find no justice because the judiciary is dominated by fundamentalists. A growing number of women, seeing no way out of the suffering in their lives, have taken to suicide by self-immolation.

This week, US vice-president Joe Biden asserted that “more loss of life [is] inevitable” in Afghanistan, and that the ongoing occupation is in the “national interests” of both the US and the UK.

I don't believe it is in your interests to see more young people sent off to war, and to have more of your taxpayers' money going to fund an occupation that keeps a gang of corrupt warlords and drug lords in power in Kabul.

What's more, I don't believe it is inevitable that this bloodshed continues forever.

The Afghan people want peace, and history teaches that we always reject occupation and foreign domination.

## **“The Election Is A Showcase For The US Government To Deceive People Around The World”**

**Despite her own rise within the Afghan electoral system, she [Malalai Joya] says there is no functioning democracy in Afghanistan under current conditions.**

**“The election is a showcase for the US government to deceive people around the world,” she told the anti-war meeting in London.**

**“We have a proverb - an old donkey but a new saddle,” she added, to laughter from the audience.**

**“It's not important who is voting, but who is counting the votes.”**

She said her own case was indicative of the poor state of the democratic system in Afghanistan.

She pointed out that she had been barred from parliament, effectively shut out from the Afghan media, and was in constant danger - so much so that she needed to wear an all-encompassing burka when in public in Afghanistan, to hide her identity.

But at the same time, she said, many parliamentary seats were occupied by “criminal warlords” who should never have been allowed to stand for election in the first place.

And she said the advances claimed for women following the overthrow of the Taliban were largely illusory.

**“No nation can donate liberation to another nation,” Ms Joya said, to loud applause from the audience.**

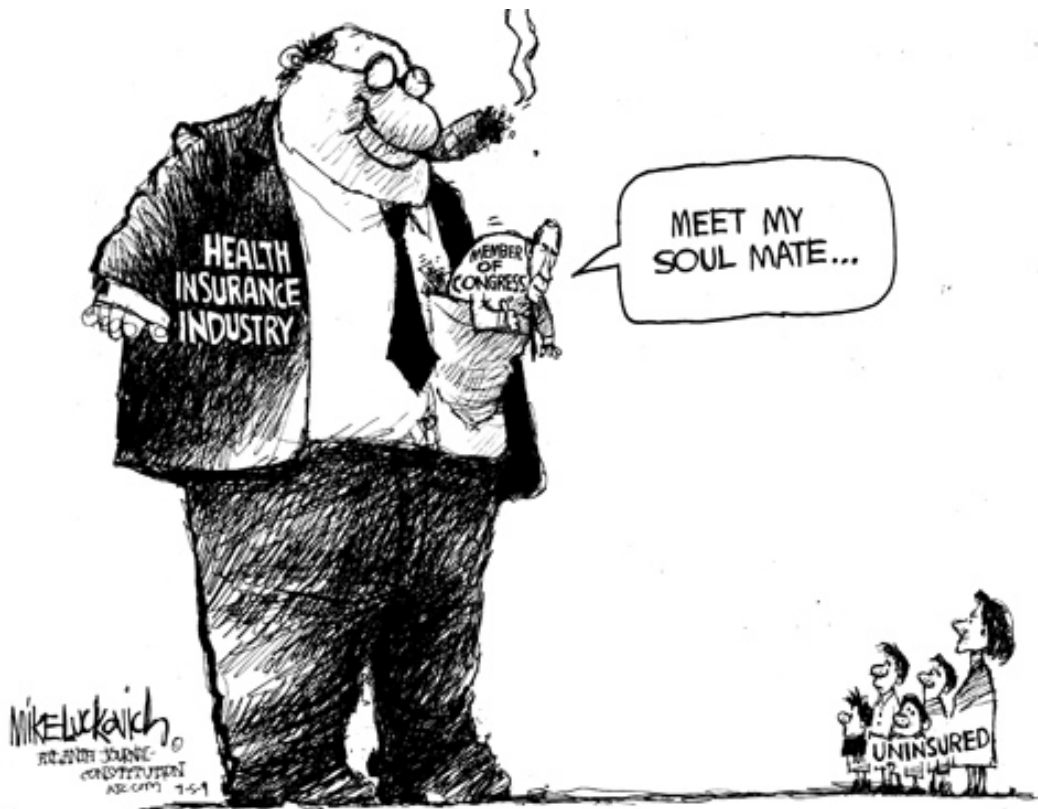

As the Obama administration and Congress try to forge a legal framework for detaining suspected terrorists, they might want to take a close look at what's happening at the federal district courthouse just a short walk down Pennsylvania Avenue from both the White House and the Capitol.

Trial judges there have quietly decided 31 of some 200 cases brought by Guantánamo inmates seeking freedom.

Dossier by dossier, the jurists have answered the core questions that policy experts have been addressing in theory: When can the president place someone in preventive detention, and how solid does the evidence need to be?

President Obama, like George W. Bush before him, has claimed the power to detain not only Qaeda and Taliban members, but also those who “support” them.

Last year the Supreme Court ruled that the courts can scrutinize these detention decisions and overturn them if they are invalid. But the court didn't say exactly what a valid detention looks like, and Congress hasn't stepped in to make it clear.

Thus the federal judges in Washington have had to develop their own guidelines — functioning, in essence, as the country's national security court.

**Twenty-six detainees have won their lawsuits, known as habeas petitions, while five have lost. So far, the Obama administration has filed just one appeal.**

**Seventeen of the 26 detainees who've been cleared for release by judges remain in custody.**

# **The Real U.S. Unemployment Rate Hits A 68-Year High**

July 25, 2009 by John Miller, Global Research [Excerpts]

Although you have to dig into the statistics to know it, unemployment in the United States is now worse than at any time since the end of the Great Depression.

From December 2007, when the recession began, to May of this year, 6.0 million U.S. workers lost their jobs.

The official unemployment rate hit 9.4% in May—already as high as the peak unemployment rates in all but the 1982 recession, the worst since World War II.

The comprehensive U-6 unemployment rate adjusts the official rate by adding marginally attached workers and workers forced to work part time for economic reasons to the officially unemployed.

The BLS [Bureau Of Labor Statistics] calculates the official unemployment rate, U-3, as the number of unemployed as a percentage of the civilian labor force. The civilian labor force consists of employed workers plus the officially unemployed, those without jobs who are available to work and have looked for a job in the last 4 weeks.

**To find the U-6 rate the BLS takes that higher unemployment count and divides it by the official civilian labor force plus the number of marginally attached workers.**

**Accounting for the large number of marginally attached workers and those working part-time for economic reasons raises the count of unemployed to 24.0 million workers for May 2009.**

**Those numbers push up the U-6 unemployment rate to 15.9% or a seasonally adjusted rate of 16.4%.**

Why is the real unemployment rate so much higher than the official, or U-3, rate?

First, forced part-time work has reached its highest level ever, going all the way back to 1956 and including the 1982 recession.

In May 2009, 8.8 million workers were forced to work part time for economic reasons.

Forced part-timers are concentrated in retail, food services, and construction; about a quarter of them are young workers between 16 and 24.

The number of discouraged workers is high today as well.

In May, the BLS counted 2.2 million “marginally attached” workers. That matches the highest number since 1994, when the agency introduced this measure.

## **Minimum Wage Stuck In The 1950s; “Anyone Who Thinks The Minimum Wage Shouldn't Be Raised Should Try Living On It”**

Are you better off than you were 40 years ago?

Not if you're a minimum wage worker.

It would take \$9.92 today to match the buying power of the minimum wage at its peak in 1968, the year Martin Luther King died fighting for living wages for sanitation workers.

**In today's dollars, the 1968 hourly minimum wage adds up to \$20,634 a year working full time.**

**The new federal minimum wage of \$7.25 comes to just \$15,080.**

**That's \$ 5,554 in lost wages.**

The minimum wage is stuck in the 1950s.

With the [recent] raise, the minimum wage is higher than 1950's inflation-adjusted \$6.71, but lower than the 1956 minimum wage of \$7.93 in today's dollars.

In 1968, the richest 1 percent of Americans had 11 percent of national income. By 2006, they had 23 percent -- the highest share since 1928, right before the Great Depression.

"Anyone who thinks the minimum wage shouldn't be raised should try living on it," says Phillip Rubin, CEO of Computer Software for Professionals in Oakland, Calif.
